



TERMS & CONDITIONS - 2020

1

Rate proposals are subject to acceptance within 30 days, activated proposals are subject to review after 90 days and adjust the rates if volumes vary substantially from information given.

2

Rates are subject to renewal one (1) year from date of acceptance (unless otherwise specified in writing), continued application of rates is conditional on account being in good standing at all times.

3

All rates are based on a minimum density of 10 pounds per cubic foot (i.e. 40"x48"x48"= 53.3 cubic feet @ 10 lbs. = as 533 lbs. Weight), unless otherwise specified in writing. All shipments will be cubed at actual dimensions and /or floor space occupied, or if dimensional information is not provided, by default at 48 x 40 x 48 per pallet. Any pallet(s) received where the height is 52" or greater, or is non-stackable by other pallets from the same shipment, will be subject to cubing to 96" to avoid top loading damage.

4

(SSF) - A single shipment picked up at one time and place, unaccompanied by any other shipment from the same pickup site will be subject to an absolute minimum freight charge of \$90.00. The absolute minimum freight charge is not inclusive of fuel, applicable taxes or accessorial fees.

5

All shipments are subject to applicable taxes (GST/ QST / HST) and fuel surcharge, and they are not included in rate quotations. All shipments are subject to Bill of Lading Conditions of Carriage (at the back of SPEEDY bill of lading).

6

All shipments are subject to applicable fuel surcharge (FSC) based on the Freight Carriers Association of Canada (FCAC) currently published rates, updated weekly. **LTL FSC** is applicable to any shipment with an actual weight, dimensional weight or rated as weight less than 10,001 lbs or less than 16 skids or up to 32' of trailer space. **FTL FSC** is applicable to any shipment with an actual weight, dimensional weight or rated as weight greater than 10,000 lbs or more than 15 skids or greater than 40' of trailer space.

A Full Load Rate (FTL) is applicable to any shipment that consists of 20 skids or greater and/or 40' of trailer space.

8

All shipments require a proper bill of lading with all pertinent information (i.e. shipper's and consignee's full name, address, phone numbers, prepaid/collect or third party billing, numbers of pieces-skid/carton/crate/etc., total weight and/or cube, appointment time, and any special delivery instructions). Postal codes with each address must be provided.

All bills of lading not marked prepaid or collect or third party billing will be deemed as prepaid – or freight marked collect where consignee refuses to pay – delivery will be released and treated as prepaid.

Second delivery will be charged out at current applicable rates, and if "in bond" service is required, the shipment will be rated as second delivery charge.

10

All pickup requests must notify SPEEDY dispatch before noon in order to facilitate same day pickup (weather permitting).

11

Carrier is not liable for loss, damage or shortage of any goods carried under the bill of lading unless notice of same as clearly indicated on the bill of lading at the time of delivery. The statement of claim must be filed within nine (9) months from the date of shipment for complete shortages and within two (2) months for partial shortages or damages. A copy of the paid freight bill must accompany the claim. Liability (\$2.00/pound) applies only to the damaged and/or missing portion of the shipment, not the entire weight. If a commodity is determined, and/or identified, to be used/refurbished/return then the limit of liability will drop to \$0.10/pound per piece damaged and/or missing.

Carrier is not liable for non-compliance fines of any type.

13

Terms of payment --- **Net 30 days** from the date of pick-up. Interest will be charged on any amounts outstanding after the due date. Interest will be charged at a rate of 2% compounded monthly - or, a rate of 26.82% per year.

1% of Declared Value in excess of \$2.00 / Lb - MIN \$10.00 / MAX \$500.00

- 11.20 **RE-WEIGH CHARGE (RWF):**

- 11.21 **ATTEMPTED PICK-UP CHARGE (APU) :**
\$75.00 / per occurrence
- 11.22 **CROSS-DOCK CHARGE (CRF) :**
\$2.50/CWT - MIN \$35.00 / MAX \$200.00 per shipment
- 11.23 **LUMPER FEES (LMF) :**
\$20.00/per skid - MIN \$50.00 / MAX \$200.00 per shipment
- 11.24 **Over-Length Fee (OLF)**
\$175/shipments containing one or more articles that are equal to, or in excessive of, 10 feet in length.
- 11.25 **Notification before delivery (CAF)**
\$25/ per shipment. When bill of lading requests that carrier notify consignee prior to delivery by any means of communication.
- 11.26 **Reconsignment before delivery (RCF)**
\$40/per shipment. When, prior to being sent out for delivery, the consignee address on the original bill of lading is requested to be changed to an address within the same local terminal delivery area.
- 11.27 **Paper Invoices (PDF)**
\$5/per invoice. Applies when customer requests paper invoices in lieu of, or in addition to, receiving electronic invoices.
- 11.28 **Pallet/Dunnage Removal (PRF)**
\$5 per pallet, minimum \$25/per shipment. When at time of delivery carrier is required, or requested, to remove the pallet(s) or packing materials, by either the shipper or the consignee.
- 11.29 **Airport Pickup Fee (AIF) :**
